INFORMATION SHEET 4. PARTICIPANT COMMITMENT -BACKGROUND

Climate Change and Greenhouse Emissions Reduction Act 2007

In 2007, South Australia enacted the *Climate Change and Greenhouse Emissions Reduction Act*, making South Australia the first place in Australia to legislate targets to reduce greenhouse emissions.

The legislation sets out three targets based around reduction of greenhouse gas emissions, and increasing the proportion of renewable energy generated and consumed in South Australia.

Wine Industry Sector Agreement

In response to the need to achieve emissions reductions, the South Australian Wine Industry Association and the Wine Grape Council SA entered into the first Sector Agreement with the State Government in 2008. This two year project will inform the wine industry of issues surrounding climate change, while encouraging and assisting industry to measure and report their carbon footprint.

Participant Commitment

The South Australian Wine Industry Sector Agreement also allows for participants to enter into underlying agreements, a commitment to report on greenhouse gas emissions for the 2009/2010 year using the Australian Wine Carbon Calculator. You can show your commitment by filling out the attached form and returning to the Project Manager at the South Australian Wine Industry Association.

Information that you provide in the participant commitment form is for data collection by the South Australian Wine Industry Association and Wine Grape Council SA only, there will be no reporting of individual information, only aggregated data.

By signing the Participant Commitment you are not legally bound to provide your data, but showing your commitment to endeavour to measure and report your Scope 1 and 2 (and optional Scope 3) greenhouse gas emissions.

Assistance with using the Australian Wine Carbon Calculator, including provision of tools and information on how to collect the data will be provided through regional workshops in 2009/2010 and documents provided on the South Australian Wine Industry Association website www.winesa.asn.au.

Note: Any company required to report under the National Greenhouse and Energy Reporting System, can provide their Scope 1 and 2 emissions (and optional Scope 3) to the Wine Industry Sector Agreement for inclusion in the project.
